Some of the topics were: a High School Essay Contest - "Your Vote is our Future", creation of Voter button for use in voter registration events, "Remote the Vote", a countywide effort to get out the vote, creation of a How to Vote Video, creation of a Forum in a Box project, distribution of Get Out the Vote magnets and providing AV equipment to local Leagues for use in Voter Service projects and Public Education meetings.
