Water Availability & Quality in San Juan County



Kyle Dodd, Environmental Health Manager for San Juan County, and **Ethan Schmidt, Environmental Health Specialist**, will address this timely issue, particularly in light of population growth and climate changes that could have a significant impact on water availability and quality in our county. While many residents obtain their water from municipal sources, others get theirs from private wells, HOA systems and other sources. The importance of this issue was highlighted last year when health concerns were raised over well contamination along with the discussion around water rights and salt-water intrusion.

In addition to helping us all become more informed about water safety and availability, the March meeting will highlight legislative

and other strategies to address these important issues.

Kyle Dodd has been the Environmental Health Manager for San Juan County Health & Community Services since 2014. In this capacity, he oversees program staff working in the areas of on-site sewage, drinking water, food protection and solid waste. He has over 25 years' experience working in local health jurisdictions in Washington. He spends time outside of work as a volunteer firefighter/EMT responding with both San Juan Island Fire & Rescue and San Juan Island EMS. Other interests include hiking and camping across the West.

Ethan Schmidt is an Environmental Health Specialist with eight years of experience working in the Drinking Water Program at San Juan County Health & Community Services. Originally hailing from northern Wisconsin, he studied Environmental Science and Economics at Northwestern University before making his way out to the San Juan Islands. Ethan enjoys working with the public and helping people navigate the challenges of water availability permitting in the islands. In his spare time, you can find him playing pickleball, skiing, or exploring the area.

LWVSJ Happenings Recap of the February Membership Meeting

Our February meeting was well attended both in person and via Zoom. We were honored to have **Secretary of State**, **Steve Hobbs** and **County Auditor**, **Natasha Warmenhoven** address the issue of election integrity and the steps that they take to ensure this in the upcoming primary and general elections. As the League continues to fight for the implementation of voting systems and procedures that are secure, accurate, recountable, and accessible, it is important to have the capacity to rebut misinformation and address cyber and other threats that may impede smooth election outcomes.

Both speakers discussed the specific procedures in place at the state and local levels to protect elections from outside interference. The Secretary of State spoke about the

importance of using paper-based systems, including voter verifiable paper audit trails; independent testing; pre- and post-election audits; and the physical security of tabulation equipment. His office has worked to ensure that counties have state-of-the-art equipment and follow IT industry best practices. Before ballot tallying equipment can be used in Washington State, they must be certified by an independent testing lab. Our county auditor described how these provisions are implemented at the county level to ensure election integrity. She emphasized the importance of transparency and reminded the audience that voters have the right to observe the way in which votes are tallied. She also offered to brief other organizations and groups about the procedures used in San Juan County. The lively question and answer session that followed allowed participants to delve into more specific issues related to elections. Countdown to Local News Concurrence at the National League Convention

This June, delegates from state and local Leagues across the country will gather at the nation's capitol for the national convention of the League of Women Voters. At this convention, many delegates will work to gain national concurrence for the LWVWA's **Local News and Democracy position**.

The delegates from each League in our state can, and likely will, voice their own perspective. A delegate need not be in favor of concurrence to attend the national convention. The final number of delegates that can be sent from Washington Leagues to the national convention is determined by the official number of members in the state. This information will be available in a few weeks. Our goal is to send as many League members from Washington as possible—not just the members of the Local News and Democracy Committee.

In the meantime, work toward national concurrence of our Local News position is underway. Here's a brief update:

- Each state and local League across the country have been asked by LWVUS to respond to a Program Planning Survey by March 10. Part of this survey is to indicate if that League supports the LWVWA bid for national concurrence on our Local News position. At least 13 local Leagues in Washington have already indicated their support.
- At some point, likely in April, we will learn if the LWVUS Board of Directors will recommend the position for concurrence at the national League convention.
- To spread awareness on the importance of national concurrence on our Local News
 position, the members of the LWVWA Local News Committee have been available to
 present workshops on how national concurrence on our position would enable
 Leagues across the country—including LWVUS—to advocate for legislation or other
 efforts that support local news and media literacy. A number of states and
 communities have proposed such legislation, including New York and Colorado.

We recognize that attending convention is costly for individuals, which is why local Leagues are encouraged to host fundraising events to help offset a portion of the delegate costs. The LWVWA is also looking at possible grants from corporations and interested organizations to help offset a portion of the costs for delegates.

Voter Services: Candidate Debates & Forums

Hearing and seeing candidates engage in healthy debates before an election is an important part of our democracy. Candidate debates and forums help us determine which candidates align with our values and which ones we want to support with our votes. Every year, state and local Leagues host candidate debates and forums for candidates running at all levels of government, from congressional races to statewide offices, city government, local school boards, and everything in between. Due to our deep roots and long history of

nonpartisanship, communities nationwide have put their trust in the League to host these events.

In the 1970s and 1980s, the League of Women Voters sponsored the televised presidential debates. In 1976, the League won an Emmy award for Outstanding Achievement in Broadcast Journalism.

The LWVWA Partners with KIRO TV for 2024 Debates

Recently, The League of Women Voters of Washington announced that they will be working with KIRO TV to present Senatorial and Gubernatorial debates for the 2024 Election. These debates will be held in October.

The LWVWA will be holding other statewide debates as well. Currently, there are also plans for primary forums for

Attorney General, Commissioner for Public Lands, and the Superintendent of Public Schools.

Breaking Down the Legislature

This is the final week of the 2024 Legislature. As noted in "This Week in the Legislature", the agenda is quite limited. The legislators will be busy behind the scenes negotiating the final floor votes for the supplemental budgets and other matters that they have chosen to hear.

As a recap, here's where we've been (weeks are rounded) in this 2nd session of the biennium:

- Weeks 1 to 3.5—Committee work for policy bills in the chamber of origin
- Weeks 3.5 to 4—Committee work continued for fiscal bills
- Week 4 to 5—Passage of bills in house of origin
- Week 5 to 6—Committee work for bills passed by the opposite chamber
- Week 6 to 7—Committee work for fiscal bills from the opposite chamber
- 4 days, Week 7—Passage of bills from the opposite chamber
- 4 days, Week 8—Final passage of final budgets and initiatives (if any)

This is a very time-limited, intense process. Legislators must work very hard to get their bills passed in any supplemental session, but this year there were more bills introduced than ever before, making the time constraints even harder.

The position of **Action Committee Chair** is opening up and we are looking for a person from our membership who could step into this role. The Chair and other members of Action Committees speak with individual lawmakers, lawmaking bodies and partners to gain support for a League position, initiative, issue or specific legislation pending in Olympia or San Juan County. LWVWA provides training and information for members of the committee. During each legislative session, members of the league work to establish personal relationships with legislators to gain credibility and serve as a resource with lawmakers and with the community at large.
