### Report on the "League Conversation" on March 27, 2018

Yakima River Basin Water Enhancement Project (or YRBWEP) is a complex, multifaceted project whose objective is to ensure the sustainability of the water supply in the Yakima River Basin and, therefore, the sustainability of the economy of the three counties of south central Washington: Kittitas, Yakima and Benton.

Stakeholders in the project include 17 city governments, the three county commissioner boards, all 5 irrigation districts, 15 conservation organizations, federal and state elected officials, the Confederated Tribes and Bands of the Yakama Nation, the Bureau of Reclamation and the Washington Department of Ecology.

Historically, the project began in 1977, with the adjudication of surface water rights among the Yakama tribe, the Washington State Dept. of Ecology and the Bureau of Reclamation. Thereafter, the increasing number of drought years led to the recognition among federal, state and local stakeholders that something had to be done if the river basin was to continue to sustain agriculture and improve fish passage as required by the declaration of salmon as an endangered species. A trigger for the YRBWEP project was the failure of the Black Rock dam proposal in 2009. According to Wendy, everything that has been spent on the multipronged YRBWEP project over the last 8 to 10 years has not come anywhere near the cost estimate of the Black Rock proposal (which, itself did not have the approval of the Yakama nation to use Columbia River water).

YRBWEP has continued since 2009 because it requires consensus among stakeholders respresented on the YRBWEP Workgroup Committee, and because (in my opinion) every stage of the project has been open and available for public scrutiny. YRBWEP brings together advocates of the agricultural economy and advocates of fish passage restoration. Both communities must answer to the needs of the entire ecosystem or neither achieve economic and ecological sustainability in the Yakima River Basin. Wendy and Lisa credited the leadership of Dan Silver, consultant, as a facilitator and Urban Eberhart, Manager of the Kittitas Reclamation District, an enthusiastic supporter.

What the YRBWEP has accomplished in a continuing coordination among stakeholders is extraordinary. Wendy remarked that the California Sacramento River Basin agricultural area has not been able to address their critical need for water sustainability because currently their "stakeholders are at war." And, the project may be

internationally extraordinary. Wendy Christensen (with the newly appointed Director of Ecology, Thomas Tebb) recently returned from an international conference on water sustainability in Brazil, where she presented YRBWEP to an international gathering.

The project is complex and multi-faceted. Seven projects throughout the basin "all move forward together" and "all required continuing compromise" among the stakeholders. Wendy presented detailed overviews of three projects:

1) the Lake Kachess to Lake Keechelus pipeline and the new juvenile fish release construction at Kachess, 2) the Cle Elum Pool Raise and Fish Passage and 3) the Teanaway Forest land exchange and watershed restoration. Lisa Bernanke, of Trout Unlimited, gave us an overview of the volunteer work in riparian restoration of the Manastash Creek and its tributaries in the Upper Valley.

Detailed information about current restoration projects is available on the YRBWEP website. Meeting notes from the public meetings of the YRBWEP Work Group will give you some insight into the opposition to various aspects of the project. Under "Acquavella Adjudication" you can find additional detailed background information on the forty-year adjudication of water rights in the basin. Background on various aspects of YRBWEP can be found on other websites: Yakama Tribe Fish Restoration, Teanaway Forest restoration and recreation projects, the Washington State Department of Ecology and the Bureau of Reclamation for Eastern Washington.
