### **Our Failing Health Care System**

Dr. John Geyman was our guest speaker for the March meeting on health care. He says a single payer system would be far more efficient than a multi-payer system. It would have more leverage to reduce waste and it would provide a structure for more accountability than we have today. Everyone would contribute to its funding on a shared and equitable basis.

President Obama's plan to let people keep what they have defeats the purpose. It puts insurance companies in competition with a national health care system. This competition will result in higher prices and duplication of expensive facilities. The insurance companies can refuse people with high health care needs and just insure the young and healthy, putting the burden on the national health care system.

What would a national health care system look like? Everyone would have a card assuring payment for all necessary care. You would have free choice of physicians and hospitals. Physicians and hospitals would remain independent and non-profit, negotiating fees and budgets with the National Health Plan. Local planning boards would allocate expensive technology. The public agency would process and pay bills. This would result in a cost savings of \$3 billion in one year.

The advantages of such a plan would assure access for all Americans with a cost savings each year. Administrative simplicity and decreased overhead would result. Medicare's current overhead percentage is 3%. Compare that to the 15% to 20% for private insurance companies. This plan would distribute risk and responsibility to finance care and to improve access, cost, and quality care.

Dr. Geyman is writing his seventh and last book on health care. *Do Not Resuscitate: Why the Health Insurance Industry is Dying and How We Must Replace It* came out in 2008 and I believe that all of his books are in our library.

Old Business.

Minutes of the March meeting were approved with changes.

New Business.

Susan suggested that one of the membership programs for the coming year be an exercise for members and their guests to take the test that is used to become a citizen of the US. This is especially appropriate since the civics requirement for graduation from high school has been adopted for Washington schools.

### LEAGUE OF WOMEN VOTERS OF WASHINGTON CALLS FOR STATE TAX REFORM

The House and Senate both released their 09-11 budget proposals this week; they join the Governor's plan that was presented in January. Before April 26, when the Legislature adjourns, the two houses and the governor will reconcile their proposals into one budget.

After using spending reductions already made in this current year's budget and the several billion \$\$ infusion of federal funds from the American Reinvestment and Recovery Act, lawmakers are still left with a \$4 billion shortfall. While there are differences in priorities among the 3 budgets, what is not different is that they all rely on spending cuts alone to make up the remaining \$4 billion. The cuts being proposed will have devastating effects on just about every area of state-funded services and programs, and will impact the future of our state for decades to come.

Here are just a few of the cuts being considered:

- Eliminate 10,000 higher ed. enrollments or raise tuition by 10-13% for community colleges and 14-17% for universities
- Reduce or eliminate I-928 funds for smaller class sizes K-12
- Cut 75% of funds to help equalize funding for poorer school districts
- Reduce state pre-school program slots for 179 children
- Reduce number of people on the Basic Health Insurance Plan by 40,000
- Reduce funding for WorkFirst program (at the very time there are no jobs)
- Cut spending on habitat and wildlife protection, land management, water management, watershed planning and implementation, flood management
- Move all money from dedicated funds into the operating budget – for example, the Clean Water and Model Toxics Control accounts

These budgets create painful cuts in the social safety net and hurt the very people most burdened in this economic environment. The cuts in education – pre-school to college – hamper investment in our future. And, cuts in climate change and environmental protections put us all at risk.

The budgets reflect both the current economic downturn and the flaws in the state's tax structure. Not only is our tax system one of the most regressive in the nation, it also provides one of the least dependable sources of revenue to any state, creating a "boom and bust" cycle in the state budget that is an exaggeration of the ebb and flow of the economic cycle. The League of Women Voters of Washington believes that it is time to reform the tax system and to correct some of its flaws

through a progressive tax on income. We look forward to working with our state legislature to develop a balanced tax structure that is fair, adequate, flexible, and has a positive economic impact.
