To register to vote, you must be:

- A United States citizen
- 18 years old by the date of the next election
- A legal resident of Washington
- Not convicted of a felony

All elections in San Juan County are conducted by mail. Ballots are mailed to all registered voters 20 days before an election. Completed ballots must be postmarked or returned to the Elections Department at the San Juan County Courthouse by the close of business on Election Day.
