How We Determine Legislative Priorities

- * League is non-partisan
- * Legislation must be supported by a League position
 - League positions reflect membership understanding and agreement on a particular public policy issue
 - Following studies and adoption at convention

Criminal Justice Positions

- * In 2021, LWVWA adopted, by concurrence, the LWV California Position on Criminal Justice
- LWVUS adopted this same position in 2022
- * This new criminal justice position supports "a criminal justice system that is just, effective, equitable, transparent, and that fosters public trust at all stages"

Other LWVWA Criminal Justice Positions

- * LWVWA also has positions in the following areas:
 - * Adult Corrections (1981)
 - * Court System (1968-77)
 - * Juvenile Justice (1976)
 - * Drug Abuse (2005)
- * Many of these positions need to be updated!

Criminal Justice Focus Areas

- Pretrial (includes police reform)
- * Trial/Sentencing
- * Prisons
- * Reentry
- * Juvenile Justice

- * Families who have lost loved ones to police violence
- * Victims and survivors of crime

2024 Legislative Priorities

- * Traffic safety (HB 1513)
- Attorney General civil rights (HB 1445)
- Independent prosecutor (HB 1579)
- Retroactive relief for juvenile points (HB 1324+)

HB 1513 - Traffic Safety

- * Efficient use of police resources Officers would focus on stopping behaviors most likely to cause injury or death on the road.
- * Racial equity Research shows that Black and brown folks are over at pulled disproportionate rates for minor violations.
- * Help for drivers Creates a community fund to fix broken taillights and other defects.
- * 2023 status: Got stuck in House Rules Committee

HB 1445 – AG Civil Rights

- * Civil accountability for law enforcement agencies showing a pattern or practice of misconduct
- * Current federal pathway is slow
- * 2023 status: Got stuck in House Rules Committee

HB 1579 – Independent Investigations

- * Prosecuting officers for criminal misconduct involving deadly use of force
- * Takes cases from Office of Independent Investigations
- * 2023 status: Got stuck in House Rules Committee

Sentencing Reform

- * Several sentencing reform bills that we supported in 2023 will be reintroduced in 2024:
 - * Resentencing individuals whose juvenile points lengthened their sentences (HB 1324)
 - * Allowing certain people incarcerated before age 25 to seek review for release (HB 1325)
 - * Eliminate mandatory "stacking" of certain sentencing enhancements, permit earned release (HB 1268)

Improving Prison Conditions

- * Rep. Peterson plans to reintroduce 1087 to limit the use of solitary confinement in Washington prisons
- * The bill:
 - Limits the time people can be held in solitary
 - Improves the conditions of those being held in solitary
 - * Prohibits the use of solitary for vulnerable people

Improving Prison Conditions (cont'd)

* Restoring the vote to incarcerated individuals (Rep. Simmons)

Defending against Rollbacks

- * Youth access to counsel
 - * HB 1140 took effect in 2022
 - Created an attorney hotline for youth who have been detained by police
 - Exception for imminent threats
- * Vehicle pursuits
 - * 2021 Imposed strict limits on when police can pursue a vehicle, banning car chases for low-level crimes such as theft. Raised legal standard to pursue for violent and sex crimes.
 - * 2023 Lowered legal standard back to reasonable suspicion for violent/sex crimes.
 - * 2024 Initiative to the legislature would reduce legal standard to reasonable suspicion that person has broken the law, pursuit is necessary to apprehend them, and they threaten public safety
